

## General Meeting February 17, 2010

Meeting was called to order at 7:40 pm. Attendance was taken and the minutes from the last meeting were reviewed.

### **Treasurer's Report: Patrick McGrath**

- The Association needs to be aware of any trainer that is getting paid for their services.
